Lifeguard Staffing Guidelines: All pool parties require additional lifeguards

<u>Number of People at party</u>	<u>Additional Lifeguards Required</u>
Up to 25 people	1 lifeguard
26 to 60 people	2 lifeguards
61 to 100 people	3 lifeguards
101 or more people	4+ lifeguards

Lifeguards will be charged at a rate of \$18.00 per lifeguard hour, with a minimum of \$27.00 per event.
 One additional lifeguard is required for any teenage party, college age party, or for any party involving alcoholic beverages.

- ** # of people attending party” is based on the TOTAL PARTY ATTENDEES, not estimated swimmers.
- Resident must provide one chaperone for each 10 people at a teenage or college age party. Chaperones must be 25 years of age or older.
- Resident will be billed for any additional time the lifeguard(s) spend cleaning up after the party.
- Payment of Party Fee, Lifeguard Fee, and refundable deposit must be submitted with party request form. The deposit will be refunded within fourteen days following party if party area is in good condition and clean of all party debris.
- Pool Rules must be followed at all times. Pool rules will be consistent with those enforced during normal swimming hours.
